Article 4 - Section 6

Insert as paragraph (B) the following:

Create new paragraph known as paragraph (C)

A member who has failed to contribute to the financial support of the Church in accordance with paragraph B of this article without satisfactory explanation shall not be privileged to vote or hold office.

Article 5 - Vacancies

The following to be known as Paragraph 2

When a vacancy on the Board exists, the President shall have the power to appoint a new member to the Board from the eligible list of the last election, the man having received the highest number of votes in said election shall be the first one named and if he declines, the next one shall be placed on the Board. In the event all men on the eligible list shall decline, the vacancy shall remain vacant until the next election for members of the Board.

Paragraph 2 in block to be known as paragraph 3.

Page 10

Article 7 Sect. 1-

Create a new paragraph known as B, as follows.

The salary of the Pastor shall be fixed by the congregation on a flat basis at either a regular quarterly meeting or at a special meeting called for the purpose. No expenses of any kind shall be allowed at any time, with the exception of Conference expenses.

Article 7 - Section 2 - Paragraph B

Strike out entire paragraph and substitute the following:

A Committee of three shall be appointed by the congregation to guide it in its choice. This committee shall take due notice of the candidates' names by the district president. In addition, the names of ^{any} candidates who may be duly qualified shall also be considered by the congregation. A reasonable number of ministers shall be given an opportunity for trial sermons. The minister receiving the majority vote in the special meeting called for the purpose shall be declared elected.

Strike out paragraph C and substitute the following:

The election of a pastor shall take place at a special meeting of the congregation on the Monday following the last trial sermons.

Article 10 Amendments - ^{Paragraph A} Page 15
Strike out the entire paragraph
and substitute the following.

Amendments and by laws to this con-
stitution shall be submitted to the
president in writing signed by 3
voting members of the Constitution in
good standing. The President shall

present these at the next congregation meeting, unless an emergency exists whereupon the President shall immediately call the congregation in special session. The presentation of any amendments or by laws shall be considered the first reading. Action on the proposed amendments or by laws shall be taken at the next meeting following the one at which they were presented. However in the event of an emergency immediate action can be had on the day the amendments or by-laws are presented by special motion and carried by two third votes of members present to set aside rules governing this paragraph. A two third vote of the members ~~as~~ present is required for the adoption of any and

all amendments or bylaws to
this constitution
