Attached is a letter from the Price Company which I hope you will present to the Council for their approval. I am attaching a copy of the letterhead used by the Church for any changes you may care to make.

Many persons are complaining about not having a pay phone to use in Friendship Hall. I have heard rumors that the various organizations would be willing to share in this expense. I have taken the liberty to check into this with the C & P Telephone Company and these are the figures they gave me: Semi public telephone will cost a quaranteed 39¢ per day or an overall charge of \$11.70 per month, plus tax. If we meet the guarantee by having \$11.70 or more in the box at the end of the month we are only billed the tax on \$11.70. However, if we do not have \$11.70 in the pay box at the end of the month we will be billed whatever the shortage is, plus the tax. On low paying phones (such as we might have) they do not collect the money each month and it may be up to 120 days before the collection is made and you are billed. Could you possibly give this some consideration?

Several members of the Ladies' Aid (Mrs. Gross, Mrs. De Vaughn, Mrs. Lillian Sauers and Mrs. Margaret Mack) housecleaned the kitchen the day after the Chicken supper, by washing down the side walls from the ceiling to the floor, cleaning out cupboards, and moving everything that could be moved and cleaning in back of it. I paid for some cleaning needs and lunch (\$1.55) out of the petty cash. These ladies' deserve a word of thanks for a job well done.
