Mr. Jones' price is \$10.00 and hour plus 9¢ per mile travelling expense from Wilmington, Delaware. Mr. Fritze was given the authority to have Mr. Jones look at the organ and have him repair it - providing cost is within reason. A motion was made to this effect by Mr. Bark and seconded by Mr. Jones.

Mr. Fritze also reported that Mrs. Binko is doing well with the choir and is building up same.

Mr. Hammerbacher will contact Mrs. Bentrup to ascertain what must be done in order to keep our Church clean and presentable at all times.

Mr. Fader advised that he received an estimate from B & B Exterminators Inc. of \$400.00 with one year guarantee

Melco Lab Inc. - \$275.00 - 5 year guarantee - annual inspection FREE Complete building would cost \$1200 to \$1800. Moth proofing \$30.00 a year. A motion was made by Mr. Hammerbacher to let the contract to Melco Lab to exterminate the necessary areas in the church bldgs. for termites at a cost of \$275.00 and a 5 year guarantee and annual inspection free, and \$30.00 for moth proofing, at future date. This will eleiminate the bugs etc. This motion was seconded by Mr. William Koehler.

Mr. Fader then brought up the idea of having the drapes cleaned and rehung. For twenty pairs of drapes to be cleaned would cost \$74.00 - Lord Baltimore Laundry. Motion was made by Mr. Louis Mueller and seconded to Mr. Fritze to have same taken care of.

Also, thanks again to Louis Mueller for installing screens in our suditorium.

## NEW BUSINESS

The following men will be eligible for re-election to the Church Council. Messrs. John Will, Max Hoffmann, Albert Fader, Ernest Jones, William Koehler, George Hammerbacher. Mr. Mark Strovel was appointed as Chiarman of this committee and Mr. Bark will be his assistant. Election will take place at congregational meeting on November 17th.

## Apartment for Pastor and Mrs. Lehmann

It was mentioned that Pastor Lehmann, if at all possible, is to be out of the parsonage by the end of September and, if necessary, his furniture will be placed in storage. Pastor and Mrs. Lehmann will move in with Mr. & Mrs. Norman Fritze until their apartment is ready at the Wellington Gate Apartments on Northern Parkway. A motion was made by Mr. Louis Mueller and seconded by Mr. George Hammerbacher to lease an apartment at the Wellington Gate Apartments for Pastor and Mrs. Lehmann for a term of two years. The Church will pay \$125.00 a month - the remainder will be taken care of by Pastor & Mrs. Lehmann.

There was no further business to come before the Church Council at this time. The meeting was adjourned with Prayer.
