Pulpit - Mr. Bark received a letter from Pastor Lloyd J. Sandt from St. James United Church of Christ, Allentown, Pennsylvania, in which he stated he would like to see and go through United Evangelical Church before committing himself to any undertakings as far as taking over as Pastor.

SPECIAL MEETING - June 20, 1961

Meeting was opened with prayer by Pastor Lehmann. Mr. Bark received a letter from Pastor Rasche from Bethlehem United Church of Christ, Chicago, Illinois with the outline of his expectations if he were to take the job of Pastor of United Evangelical Church. The council advised Mr. Bark to contact Pastor Rasche and invite him to visit with us.

Mr. Bark wrote to Pastor C. W. Ebert of St. Paul's United Church of Christ, Pottstown, Pennsylvania and received a reply in which he invited a group of men to visit with his Church on June 25th.

Rev. Lloyd J. Sandt was discussed by the men on the Church Council who had met him and it was stated that he was a very energetic man but it was stated that the congregation might not take to him. Mr. Bark is to make further contacts with Pastor Sandt and ask him if he will come and preach a guest sermon.

OLD BUSINESS:

The Church Council has reimbursed Pastor Lehmann for the money that he advanced for his recent trip to Johnson City, Tennessee.

NEW BUSINESS:

Pastor Riggs will be the Assistant Pastor from July 10th through July 13th.

Youth Fellowship will have their closing exercises for the summer. A motion was made by Mr. Marcus Strovel and seconded by Mr. Norman Fritze that the Church donate ten cases of Coca-Cola to the Youth Fellowship.

At a meeting of the Baltimore Federation of the United Church of Christ, attended by Mr. Fader and Mr. Bark, the idea of the block add for listing the Church's names in the paper came up concerning finances to pay for this add. They stated that the delegates to this meeting have no power to make any commitments for any sums of money that would be used for various reasons. It was stated at this meeting that they are thinking about starting a Day Camp and would like the churches to set up a budget of ten cents per member to be contributed to the Federation for these purposes. The Council is to take this idea into consideration upon the receipt of the next agenda published by the Federation.

Mr. Jones brought up the idea of forming a committee to look into Church Membership in order to meet the Potomac Synod apportionment paid by the Church.

There was no further business to come before the Church Council at this time; therefore, a motion was made by Mr. Ernest Jones and seconded by Mr. John Will that the meeting be adjourned. The meeting was closed with prayer.


