Reports of Committees:

PROPERTY - Mr. Hammerbacher stated that two storm windows in the Church have been broken.

Mr. Fader stated that Mr. Eckes investigated the air conditioning unit in the parsonage and Mr. Eckes said he could repair the old air conditioning unit or install a new two ton unit that would be suitable for the parsonage. The Church Council decided to have Mr. Eckes take the old unit out and repair same. A motion was made by Mr. Bark and seconded by Mr. Hammerbacher to have the old unit repaired.

The idea was brought up by Mr. Fader that a phone should be installed in the Friendship Hall for outgoing calls, and a motion was made by Mr. William Koehler and seconded by Mr. Jones that we add a dial extension to the phone in the Church Office and to install an honorary system for paying for phone calls.

Mr. Fader stated that Pastor Lehmann's typewriter was in need of repair. A motion was made by Mr. Koehler and seconded by Mr. Mueller to have the typewriter repaired.

PICNIC - Mr. Hammerbacher advised that there was a loss on the picnic of \$176.03. Church will pay half the cost of this loss.

FINANCE - Mr. Bark stated that \$5,000 was bequeathed to the Church from Mrs. Marie G. Heinz Estate. A motion was made by Mr. Bark and seconded by Mr. Fritze to place this money in an emergency fund.
